





"Student" residence permit's renewal

List of supporting documents:

✓ Identity document.

You are holding:

- O A residence card: Front and back of your residence card
- A long stay visa:
 - Page of your passport with your identity and signature;
 - O Page with the "student" visa;
 - O Page with the entry stamp/date in France.

✓ Recent e-photo.

Caution: No photo in PDF, JPEG etc.

- ✓ Proof of address less than 6 months old*:
- *The document must have been established/signed less than 6 months before your renewal application.
- O You live in a CROUS/student residence (CROUS, St Bernard, St Laurent houses, private student residence):
 - Certificate of residence ("Attestation de résidence").
 - You are a tenant or home-owner:
 - Water or electricity or gas or fixed or cell phone or internet bill mentioning your name;
 - <u>Or</u> lease agreement mentioning your name (only from an estate agency, documents between individuals are not accepted);
 - <u>Or</u> last receipt of rent mentioning your name (only from an estate agency, documents between individuals are not accepted);
 - Or certificate of home insurance mentioning your name.
 - O You live in a hotel:
 - Certificate from the hotel manager;
 - Or last month's invoice.







- You are staying with a private person (family, friend...)
- Dated and signed certificate of accommodation from your host. See PDF "[Example] Accommodation certificate_ FR-ENG";
- His/her identity card (if French/European citizen) or valid residence permit;
- Proof of residence less than 6 months old in his/her name.

✓ School certificate or proof of pre-enrolment.

Caution: If you upload a *certificate of (pre)enrollment/pre-inscription*, note that the Prefecture will mandatory ask you to provide a *school certificate* at the semester start.

<u>If you are awaiting results on Parcoursup / MonMaster</u>: screenshot of your applications. You name must be visible on the screenshot.

MSc student (ESDES): Letter from the Director of MSc programs indicating the graduation jury date.

<u>If your study includes a European mobility (exchange/internship)</u>: document established by your faculty/school/institute justifying this European mobility.

- ✓ Transcript of grades/records: transcripts for the period of time since obtaining your last visa/residence permit.
- Last diploma obtained in France (if concerned): DUEF (ILCF), Bachelor, Licence etc.
- Certificate of achievement (optional): UCLy doesn't provide this document since you have a transcript of grades.
- √ Financial resources:

Caution: monthly statements of account are not a valid

The amount of your financial resources must be equivalent to 615€/month

- o <u>"Pris en charge" = You receive money from a parent/ another person:</u>
- Bank certificate of this person proving regular transfers to your account;
- <u>Or</u> Certificate on honor completed, dated and signed by this person. See PDF "(Example) Financial responsibility_FR-ENG"
- Passport/ID card of this person.







- o <u>"Salarié" = You have a student job or you are an intern/alternant.</u>
- Pay slips of the last 3 months
 - o <u>"Ressources personnelles" = You live with your own savings:</u>
- Bank certificate of sufficient credit balance (expressed in €). For 1 academical year, the balance must reach at least 6.150€.
 - o <u>"Boursier" = You have a scholarship:</u>
- From you home country: certificate of scholarship/grant mentioning the amount and duration of the scholarship.
- From the French government or a European program: certificate of scholarship/grant mentioning the amount and duration of the scholarship.
