





## Student holding a visa as "Mineur scolarisé"

## Application for the resident permit as « Student » List of supporting documents

This list concerns students holding a visa as "Mineur scolarisé" who <u>turned 18 in France</u>. Documents must be provided the day of your appointment at the *Préfecture* (originals + copies).

List of supporting documents – Originals and copies:

- ✓ Passport:
  - Pages related to your identity and signature
  - Page with the "Mineur scolarisé" visa
  - o Page with the entry stamp (date of entry) in France
- ✓ 3 ID-photo
- ✓ Proof of address less than 6 months old:
- O <u>You live in a CROUS/student residence (St Bernard, St Laurent houses, CROUS residence, private student residence):</u>
  - Certificate of residence
    - O You are a tenant or home-owner:
  - Water or electricity or gas or fixed or cell phone or internet bill mentioning your name
  - $\underline{Or}$  lease agreement (only from an authorized body documents between individuals are not accepted)
  - Or last receipt of rent (only from an authorized body- documents between individuals are not accepted)







- You live in a hotel:
- Certificate from the hotel manager
- Or last month's invoice
  - O You are staying with a private individual (family, friend...)
- Dated and signed certificate of accommodation from your host. See PDF "(Example) Accommodation certificate".
- His/her identity card (if your host is French/European) or valid residence permit
- Proof of residence in his/her name (if the address on his/her identity card is no longer up to date)
- ✓ Scholarship certificate at the UCLy for the current academic year / semester

<u>If your study at UCLy includes mobility in another European country (Erasmus program or internship)</u>: Certificate of mobility established by your faculty at UCLy mentioning the European country and the time period of this mobility.

✓ Financial resources:

Caution: monthly statements of account are not a valid

- O You receive money from a parent/ another person:
- Bank certificate from this person proving the planned regular transfers to your account for an amount of minimum 615€/month
- <u>Or</u> Certificate on the honor of payment of the sums required to reach the amount of minimum 615€/month. See PDF "(Example) Financial responsibility".
- Proof of identity of the third party
  - You are an employee.
- Pay slips of the last 3 months
  - You have your own savings:
- Bank certificate of sufficient credit balance. The amount has to be minimum 6.150€ for a year.
  - You have a scholarship:
- From you home country: please provide a certificate of scholarship from the paying agency of the home country specifying the amount and duration of the scholarship.
- From the French government scholarship holders and beneficiaries of European programs: please provide the scholarship certificate.
