



Enrolment for the French Health Insurance

Prepare <u>all</u> documents before begging the process Missing or non-valid document will slow your enrolment.

- ✓ Proof of identity: Passeport (page with your identity and signature)
- ✓ Proof of civil status: Birth certificate with names of your parents
 + certified translation in French*

Caution: make sure to <u>not crop</u> of your birth certificate (and its translation) while scanning

Stamps must be fully legible

*The translation is not needed if edited in: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, Germany, Greece, Hungary, Iceland, Ireland, Italia, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal (archipelagos of Madeira and the Azores included), Romania, Slovakia, Slovenia, Spain (Balearic and Canary Islands included), Sweden, UK (England, Scotland, Wales, Northern Ireland, Gibraltar included)

- ✓ « Student » Visa
- ✓ Residency permit: Confirmation of validation of the « Student » visa
- School certificate
 Pre-enrolment certificate are not valid.
- ✓ Bank details with:
 - Surname & forename of account holder
 - RIB/IBAN (€ zone) or CCAN (outside € zone)
 - BIC/SWIFT
 - Bank address

Caution: bank account outside the €uro zone are not valid.

Depending on your situation, other documents may be required


Once your identity will be verified:


You will receive first your n° **provisional** Social Security number (called *NIA – Numéro d'Identification d'Attente*).

You can download the document with the number from your account (Attestation de droit).

Don't forget to bring this document to the doctor to benefit from the partial refund of your health costs.

Once your civil status (birth certificate), your right to stay in France (visa + visa validation) and your school certificate will be verified, you will receive your final Social Security number.








You will then receive a **post mail** with the form to fill to get your Carte Vitale, to complete and send back with a copy of your passport (in real size).
